WHEREAS, in response to the said advertisement, three (3) suppliers/contractors purchased bid documents and submitted its bid namely: Tahanang Walang Hagdanan, Bigay Buhay Multipurpose Cooperative and Emferyork Trading;

WHEREAS, the bidders' technical component of the bid, including the eligibility requirements were submitted on 05 October 2022 and thereafter found out that only one (1) bidder is eligible to participate that is Emferyork Trading;

WHEREAS, two (2) of the bidder's that is, Tahanang Walang Hagdanan only submitted their Comparative Income Tax Return and Financial Statement for the year 2020 and 2021 and Bigay Buhay Multipurpose Cooperative failed to submit their Bid Documents on the time specified in the ITB. Thus, both are declared disqualified;

WHEREAS, the bidders' financial component of the bid was found to be substantially complying;
