

BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF THE SINGLE CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING APPROVAL

WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (ITB) for the Purchase of one (1) unit of Police Patrol Vehicle 4x4 which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Building, RPHS – Angono and RPHS - Morong for the period covered 11 July 2022 to 01 August 2022 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implement Rules and Regulation (IRR) of RA 9184;

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the ITB is ₱1,600,000.00;

WHEREAS, in response to the said advertisement, one (1) supplier/contractor purchased bid documents and submitted its bid;

WHEREAS, the bidder's technical component of the proposal, including the eligibility requirements were submitted on 01 August 2022 and was thereafter found to be eligible;

WHEREAS, the bidder's financial component of the bid was found to be substantially complying;
