

**BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF  
THE SINGLE CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING  
APPROVAL**

**Resolution No. GS2022-141

**WHEREAS**, the Rizal Provincial Government advertised the Invitation to Bid for the bidding of Framework Agreement for IV Fluids which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS - Morong and RPHS - Angono for the period covered 01 December 2022 to 21 December 2022, in compliance with RA 9184, otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations (IRR);

**WHEREAS**, the Approved Budget for the Contract (ABC) is ₱31,203,129.00;

**WHEREAS**, the bidding of the Framework Agreement for IV Fluids was on a per lot basis;

**WHEREAS**, in response to the said advertisement, only one (1) supplier purchased bid documents and submitted its bid and that is, **Nemrac Medical and Pharma Supplies Corp.**;

**WHEREAS**, the supplier's technical component of the bid, including the eligibility requirements were submitted on 22 December 2022 and thereafter found to be eligible;

**WHEREAS**, the other supplier's financial component of the bid was found to be substantially complying;

**WHEREAS**, when the submitted bids were read, it appears that **Nemrac Medical and Pharma Supplies Corp.** submitted quotation in the amount of ₱31,008,861.00;

**WHEREAS**, the detailed evaluation of the bids was conducted after the opening of bids;

**WHEREAS**, upon careful examination and evaluation of the submitted bid offer, it was found out that **Nemrac Medical and Pharma Supplies Corp.** appears to be the single calculated and responsive price offer for the bidding of Framework Agreement for IV Fluids in the amount of ₱31,008,861.00;


**WHEREAS**, upon careful examination, validation and verification of the eligibility requirements and technical and financial component of the bid submitted by the supplier, all of the documents passed the post-qualification conducted after the bid evaluation and such has been found to be responsive;





- 2. TO RECOMMEND** for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.


