

BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF THE SINGLE CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING APPROVAL

**Resolution No. GS2023-071
Series of 2023.**

WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Purchase of Covid Antigen Nasal and Naso Swab for infection prevention and control in Rizal Provincial Hospital System which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS – Angono and RPHS - Morong for the period covered 20 April 2023 to 11 May 2023, in compliance with RA 9184, otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations (IRR);

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the IB is Two Million Five Hundred Seventy Thousand Two Hundred Fifty Pesos (₱2,570,250.00);

WHEREAS, in response to the said advertisement, two (2) suppliers/contractors purchased bid documents and submitted its bid, namely: RainPhil, Inc. and Allied Hospital Supply International Corp.;

WHEREAS, the bidder's technical component of the bid, including the eligibility requirements were submitted on 12 May 2023. Allied Hospital Supply International Corp. was able to satisfy the requirements to participate. However, RainPhil, Inc. failed to submit their BIR Income Tax Return (ITR) for the year 2022 – hence, applying the pass/fail criteria, was declared disqualified to participate in the activity.

WHEREAS, the bidder's financial component of the bid was found to be substantially complying;

WHEREAS, the detailed evaluation of the bids was conducted after the opening of bids;

WHEREAS, upon careful scrutiny and evaluation of the submitted bid proposal, it was found out that Allied Hospital Supply International Corp. appears to be the single calculated bid for the Purchase of Covid Antigen Nasal and Naso Swab in the amount of Two Million Four Hundred Fifty Eight Thousand Five Hundred Pesos (₱2,458,500.00);

WHEREAS, upon careful examination, validation and verification of the requirements, to wit: the technical component including the eligibility requirements and financial component of the bid submitted by the bidder, the documents passed the post-qualification conducted after the bid evaluation and such has been found to be responsive;


NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:


