

MINUTES OF THE MEETING OF THE BIDS & AWARDS COMMITTEE FOR THE PURCHASE OF EXPANDED NEWBORN SCREENING KIT THROUGH THE ALTERNATIVE METHOD OF PROCUREMENT (DIRECT CONTRACTING) HELD LAST 25 AUGUST 2023 AT THE OFFICE OF THE PROCUREMENT DIVISION, RIZAL PROVINCIAL GOVERNMENT, ANTIPOLO CITY AT 11:00 IN THE MORNING

WHEREAS, under Resolution No. GS2023 - 103 Series of 2023, it has been recommended and approved that the purchase of Expanded Newborn Screening Test Kit be made through alternative method of procurement, by direct contracting.

WHEREAS, the purchase shall be made at the Newborn Screening Center-Southern Luzon at Daniel O. Mercado Medical Center, Institute of Health Sciences, the single and sole exclusive distributor of Expanded Newborn Screening Kits, which submitted a quotation in the amount of One Thousand Seven Hundred Fifty Pesos (P1,750.00) per kit;

NOW THEREFORE, for and in consideration of the foregoing premises, and the provision of Republic Act 9184, otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations (IRR), the Committee agreed as they hereby agree to recommend to the Honorable Governor that the award for the purchase of Five Thousand Six Hundred (5,600) kits of Expanded Newborn Screening Test (20+ Test) in the total amount of Nine Million Eight Hundred Thousand Pesos (P9,800,000.00) be made to Daniel O. Mercado Medical Center Newborn Screening Center-Southern Luzon.
