

BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF THE SINGLE CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING APPROVAL

**Resolution No. GS2023-051

WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Purchase of Radiology Supplies for the operations of hospitals under the Rizal Provincial Hospital System (RPHS) for 1st semester 2023 which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Building, RPHS-Angono and RPHS-Morong for the period covered 03 March 2023 to 22 March 2023, in compliance with RA 9184, otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations (IRR);

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the IB is One Million Two Hundred Eighty Seven Thousand Nine Hundred Pesos (₱1,287,900.00);

WHEREAS, in response to the said advertisement, one (1) supplier/contractor purchased bid documents and submitted its bid;

WHEREAS, the bidders' technical component of the bid, including the eligibility requirements were submitted on 23 March 2023 and thereafter found to be eligible;

WHEREAS, the bidder's financial component of the bid was found to be substantially complying;

WHEREAS, upon careful examination, validation and verification of the requirements, to wit: the technical component including the eligibility requirements and financial component of the bid submitted by the bidder, the documents passed the post-qualification conducted after the bid evaluation and such has been found to be responsive;

NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

1. **TO DECLARE MEDALERT ENTERPRISES** as the bidder with the single calculated and responsive bid for the Purchase of Radiology Supplies for the operations of hospitals under the Rizal Provincial Hospital System (RPHS) for 1st semester 2023 in the amount of One Million Two Hundred Eighty Thousand Two Hundred Twenty Pesos (P1,280,220.00); and
2. **TO RECOMMEND** for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.
