

**BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF THE SINGLE CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING APPROVAL**

**WHEREAS**, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Purchase of Certificate/Diploma for distribution to different schools within the Province of Rizal which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS – Angono, and RPHS - Morong for the period covered 10 May 2023 to 30 May 2023 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implement Rules and Regulation (IRR) of RA 9184;

**WHEREAS**, the Approved Budget for the Contract (ABC) as stated in the IB is One Million Nine Hundred Thirty Two Thousand Three Hundred Pesos (₱1,932,300.00);

**WHEREAS**, in response to the said advertisement, one (1) supplier/contractor purchased bid documents and submitted its bid, that is, Omel Enterprises, Inc.;

**WHEREAS**, the bidder's technical component of the proposal, including the eligibility requirements were submitted on 31 May 2023 and was thereafter found to be eligible;

**WHEREAS**, the bidder's financial component of the bid was found to be substantially complying;


**NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby RESOLVE as it is hereby RESOLVED:**



2. To recommend for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.


