**WHEREAS**, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Purchase of Rehabilitation Equipment for the use of the Rehabilitation Clinic at RPHS - Taytay which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS – Angono and RPHS - Morong for the period covered 20 April 2023 to 11 May 2023, in compliance with RA 9184, otherwise known as the Government Procurement Reform Act and its 2016 Revised Implementing Rules and Regulations (IRR);

**WHEREAS**, the Approved Budget for the Contract (ABC) as stated in the IB is One Million Five Hundred Fifty Six Thousand One Hundred Twenty Five Pesos (₱1,556,125.00);

**WHEREAS**, in response to the said advertisement, one (1) supplier/contractor purchased bid documents and submitted its bid and that is, Paco Roman Drug, Inc.;

**WHEREAS**, the bidder's technical component of the bid, including the eligibility requirements were submitted on 12 May 2023 and thereafter found to be eligible;

**WHEREAS**, the bidder's financial component of the bid was found to be substantially complying;

**NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby RESOLVE as it is hereby RESOLVED:**



1. **TO RECOMMEND** for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.




