

BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF THE SINGLE CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING APPROVAL

**Resolution No. GS2023-104
Series of 2023.**

WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Purchase of Mini Dump Truck for distribution as incentive to different barangays within the Province of Rizal, in line with their active participation to YES to Green Program which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Building, RPHS – Angono and RPHS - Morong for the period covered 01 August 2023 to 22 August 2023 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implement Rules and Regulation (IRR) of RA 9184;

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the IB is Three Million Eight Hundred Thousand Pesos (P3,800,000.00);

WHEREAS, in response to the said advertisement, one (1) supplier/contractor purchased bid documents and submitted its bid, that is, Powertrac, Inc.;

WHEREAS, the bidder’s technical component of the proposal, including the eligibility requirements were submitted on 22 August 2023 and was thereafter found to be eligible;

WHEREAS, the bidder’s financial component of the bid was found to be substantially complying;

WHEREAS, the detailed evaluation of the bid conducted after the opening of bid resulted in the following:

WHEREAS, upon careful scrutiny and evaluation of the submitted bid proposal, it was found out that Powertrac, Inc. appears to be the single calculated bid for the Purchase of Mini Dump Truck in the amount of Three Million Seven Hundred Sixty Thousand Pesos (P3,760,000.00);



2. To recommend for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.






