

**BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF  
THE SINGLE CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING  
APPROVAL****Resolution No. GS2024- 145  
Series of 2024.**

**WHEREAS**, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Treatment and Transport of Hazardous Waste for the maintenance and sanitation of the hospitals under Rizal Provincial Hospital System (RPHS) which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS – Morong and RPHS - Angono for the period covered from 21 November 2024 to 10 December 2024 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implement Rules and Regulation (IRR);

**WHEREAS**, the Approved Budget for the Contract (ABC) as stated in the IB is Eleven Million Pesos (₱ 11,000,000.00) or Thirty Two Pesos (₱ 32.00) per kilo;

**WHEREAS**, in response to the said advertisement, one (1) supplier/contractor purchased bid documents and submitted its bid, that is, Cleanhaul Environmental Services, Inc.;

**WHEREAS**, the bidder's technical component of the proposal, including the eligibility requirements were submitted on 11 December 2024 and was thereafter found to be eligible;

**WHEREAS**, the bidder's financial component of the bid was found to be substantially complying;




**NOW THEREFORE, WE,** the members of the Bids & Awards Committee, hereby RESOLVE as it is hereby RESOLVED:



2. To recommend for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.




