

BIDS & AWARDS COMMITTEE SPECIAL MEETING FOR THE DECLARATION OF THE SINGLE CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING APPROVAL

**Resolution No. GS2024 - 055
Series of 2024.**

WHEREAS, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Purchase of Diploma Certificate for distribution to different schools within the Province of Rizal which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS – Angono, and RPHS - Morong for the period covered 05 March 2024 to 24 March 2024 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implement Rules and Regulation (IRR) of RA 9184;

WHEREAS, the Approved Budget for the Contract (ABC) as stated in the IB is One Million Fifty Nine Thousand Pesos (₱ 1,059,000.00);

WHEREAS, in response to the said advertisement, one (1) supplier/contractor purchased bid documents and submitted its bid, that is, Omel Enterprises, Inc.;

WHEREAS, the bidder's technical component of the proposal, including the eligibility requirements were submitted on 25 March 2024 and was thereafter found to be eligible;

WHEREAS, the bidder's financial component of the bid was found to be substantially complying;

NOW THEREFORE, WE, the members of the Bids & Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:


