THE SINGLE CALCULATED AND RESPONSIVE BID AND ITS RECOMMENDING  
APPROVAL****Resolution No. GS2025-024

**WHEREAS**, the Rizal Provincial Government advertised the Invitation to Bid (IB) for the Supply and Delivery of 195 sets Kiddie Table and Chairs for distribution to different Department of Education Region IV-A Sub-Offices which was posted in the Philippine Government Electronic Procurement System (PhilGEPS), LGU website and in three (3) conspicuous places, to wit: at the lobby of the Rizal Provincial Government Capitol Bldg., RPHS – Morong, RPHS- Angono for the period covered 26 February 2025 to 17 March 2025 in compliance with RA 9184 otherwise known as the Government Procurement Reform Act and its 2016 Revised Implement Rules and Regulation (IRR) of RA 9184;

**WHEREAS**, the Approved Budget for the Contract (ABC) as stated in the IB is Five Million One Hundred Sixty Two Thousand Five Hundred Pesos (₱ 5,162,500.00);

**WHEREAS**, in response to the said advertisement, one (1) supplier/contractor purchased bid documents and submitted its bid, that is, Muchi Marketing Co.;

**WHEREAS**, the bidder's technical component of the proposal, including the eligibility requirements were submitted on 18 March 2025 and was thereafter found to be eligible;

**WHEREAS**, the bidder's financial component of the bid was found to be substantially complying;

**WHEREAS**, upon careful examination, validation and verification of the requirements, to wit: the technical component including the eligibility requirements and financial component of the bid submitted by the bidder, the documents passed the post-qualification conducted after the bid evaluation and such has been found to be responsive;



**NOW THEREFORE**, WE, the members of the Bids & Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

1. **TO DECLARE MUCHI MARKETING CO.,** as the bidder with the single calculated and responsive bid for the **Supply and Delivery of 195 sets Kiddie Table and Chairs** in the amount of **Four Million Six Hundred Ninety Thousand Five Hundred Pesos (P 4,690,500.00);**
2. To recommend for approval by the Honorable Governor of the Rizal Provincial Government the foregoing findings.




