## AN ORDINANCE APPROVING THE GENERAL FUND CY 2012 SUPPLEMENTAL BUDGET NO. 3 OF THE RIZAL PROVINCIAL GOVERNMENT

#### Be it Enacted by the Sangguniang Panlalawigan of Rizal in Session Assembled:

**SECTION 3.** That the Provincial Governor and the Vice-Governor are hereby authorized to augment any item in this Ordinance from savings in other items within the same expenses class of appropriations.

**SECTION 4.** That the Provincial Governor, Hon. Casimiro A. Ynares III, M.D., is hereby authorized to enter into contract/agreement relative to the implementation of the said undertaking and that the same is hereby confirmed and ratified.

**SECTION 5.** This Ordinance shall take effect upon its approval.
